APPROPRIATION (FURTHER SUPPLEMENTARY APPROPRIATION FOR 2023-24) ACT 2024

No. 1 of 2024

An Act for the appropriation of \$82 050 000 out of the Public Account for the services of the Government for the financial year ending on 30 June 2024

[Royal Assent 7 June 2024]

Be it enacted by Her Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:

1. Short title

This Act may be cited as the *Appropriation* (Further Supplementary Appropriation for 2023-24) Act 2024.

2. Commencement

This Act is taken to have commenced on 1 July 2023.

3. Interpretation

For the purposes of this Act –

Capital Services means –

- (a) public works or property required for public purposes; or
- (b) a loan authorised by law;

Operating Services means the ordinary annual services of the Government.

4. Issue, application and appropriation of \$82 050 000

- (1) In respect of the financial year ending on 30 June 2024, the Treasurer may
 - (a) issue the sum of \$82 050 000 out of the Public Account; and
 - (b) apply that sum for the services of the Government.
- (2) The sum specified in subsection (1)(a) is appropriated.

5. Purposes of appropriation

The sum specified in section 4(1)(a) is to be applied for the purposes referred to in Schedule 1 and detailed in either of the following:

- (a) the agency information in support of the estimates for the financial year ending on 30 June 2024;
- (b) the information tabled by the Minister in support of Schedule 1.

6. Expiry of Act

This Act expires on 30 June 2025.
