1. Short title

These regulations may be cited as the *Heavy Vehicle National Law (Tasmania) Amendment Regulations 2018*.

3. Principal Regulations

In these regulations, the *Heavy Vehicle National Law (Tasmania) Regulations 2014** are referred to as the Principal Regulations.

4. Schedule 1 amended (Infringement Notice Offences)

Schedule 1 to the Principal Regulations is amended as follows:

- (a) by inserting the following definition before the definition of *HVNL* in clause 1 of Part 1:

HVFM means the *Heavy Vehicle (Fatigue Management) National Regulation*, as made under the Heavy Vehicle National Law and applied in this jurisdiction by section 5 of the Act;

- (b) by omitting “(2)” from column 2 of item 88 in Subdivision 4 of Division 1 of Part 2 and substituting “(3)”;
- (c) by omitting item 109 from Subdivision 5 of Division 1 of Part 2 and substituting the following items:
