Regulation 7 of the Principal Regulations is rescinded.

**7. Schedule 1 amended (Infringement Notice Offences)**

**EXPLANATORY NOTE**

*(This note is not part of the regulations)*

These regulations amend the *Heavy Vehicle National Law (Tasmania) Regulations 2014* by –

- (a) omitting certain provisions that are no longer required; and
- (b) updating the schedule of infringement notice offences consequent on certain changes made to the Heavy Vehicle National Law (Tasmania).
