### **1. Short title**

These regulations may be cited as the *Police Offences Amendment (Prohibited Insignia) Regulations 2019*.

### **2. Commencement**

These regulations take effect on the day on which their making is notified in the *Gazette*.

**3. Principal Regulations**

In these regulations, the *Police Offences Regulations 2014*\* are referred to as the Principal Regulations.

**4. Regulation 7A inserted**

Before regulation 8 of the Principal Regulations, the following regulation is inserted in Part 4:

**7A. Identified organisations for purposes of section 6A(3) of Act**

For the purposes of section 6A(3) of the Act, the following organisations are each prescribed as an identified organisation:

- (a) the motorcycle club known as Outlaws;
- (b) the motorcycle club known as Rebels;
- (c) the motorcycle club known as Bandidos;
- (d) the motorcycle club known as Black Uhlans;
- (e) the motorcycle club known as Devil's Henchmen.
